# ASEAN-India Summit 2023 Enhancing Prosperity and Strengthening Ties

https://cuts-wdc.org/indopacific-forum.htm The 20<sup>th</sup> Association of Southeast Asian Nations (ASEAN)-India Summit was held in Jakarta, Indonesia, on September 07, 2023, and was chaired by the President of the Republic of Indonesia Joko Widodo. Indian Prime Minister Narendra Modi had a detailed discussion with the ASEAN members about strengthening the future of the ASEAN-India partnership.

Modi placed a special emphasis on the ASEAN centrality in the Indo-Pacific region. He also highlighted the coordination between India's Indo-Pacific Ocean Initiative and ASEAN's Outlook on the Indo-Pacific. He also underlined the entail of completing the review of the ASEAN-India Free Trade Agreement at the earliest possible time.

mphasising the significance of the ASEAN-India Summit Modi said "Meeting ASEAN leaders is always a pleasure. The summit is evidence of our cooperation and common vision for the future. We anticipate cooperating in cutting-edge fields that advance human progress."

During the summit, Modi provided a 12-point proposal for enhancing the cooperation and partnership between ASEAN and India which covered a wide range of areas of cooperation. To increase the connectivity with the ASEAN, the establishment of multi-modal connectivity and economic corridor



that links Southeast Asia-India-West Asia-Europe has been proposed.

Modi also offered to share India's Digital Public Infrastructure Stack with the ASEAN counterparts. Adding to it, he emphasised the graveness of the free and open Indo-Pacific and the importance of amplifying the voice of the Global South. He said that ASEAN is the most significant pillar of India's Act East Policy.

The Joint Statement on Maritime Cooperation has shown the support of India and ASEAN in finalising an effective and substantive Code of Conduct in the South China Sea following international law and the United Nations Convention on the Law of the Sea. Apart from all these, Modi invited ASEAN partners to cooperate in addressing global challenges and issues such as terrorism, climate change and resilient supply chains for essential items.

Leaders of both parties also encourage economic cooperation between both regions. After the pandemic, there is an urgent need to strengthen the strategic and economic engagement between the two. The bilateral trade between India and ASEAN in 2022-2023 has reached up to US\$131.5bn, which is 11.3 per cent of India's overall trade. This bilateral trade is expected to become more robust soon.



## A Trans-Europe-Asia Express Journey

he Europe-West Asia-India Transit Corridor reinforces Europe's shift away from Russian energy sources in favour of supply from the Persian Gulf, a part of which is processed in India for reexport. The corridor also establishes an alternative to the Suez Canal, which is emerging as a choke point for just-in-time global supply chains.



A rail bridge between the Mediterranean and the Indo-Pacific should improve access to manufacturing planning a shift out of China, thereby supporting India's ambition of increasing its share of goods trade. (ET, 11.09.23)

#### **Economic Revival via IPEF Engagement**

This framework for economic cooperation strengthens ties between the US and the Indo-Pacific region to promote and facilitate trade, improve supply chain resiliency, enable the clean economy transition, combat corruption and improve tax administration.

In addition, by establishing high-standard labour, environmental and accountability commitments as well as facilitating coordination across borders, the Indo-Pacific Economic Framework (IPEF) puts workers and consumers at the centre of foreign economic engagement. (USDC, 31.07.23)

#### **India Seeks Bigger Role in Indo-Pacific**

Modi has given a 'guarantee' that during his third term, India will become the third largest economy, one place below China, a country with which India has been having bilateral issues for quite a while now.

#### **Strengthening Indo-Pacific Trade**

In a significant development that promises to bolster trade and commerce in the Indo-Pacific region, eight chambers of commerce from various countries have agreed to collaborate under a unified platform.

This collaborative effort is expected to stimulate economic activities in the region which already accounts for nearly US\$47tn annually. The proposal for this association was introduced at the Indo-Pacific Economic Conclave and received an enthusiastic response. (GR, 29.09.23)

#### **UK to Join Indo-Pacific Trade Group**

Kemi Badenoch, Business and Trade
Secretary of the UK has formally signed the
treaty to accede to the Comprehensive and
Progressive Agreement for the Trans-Pacific
Partnership (CPTPP) trade group in New
Zealand, kickstarting the UK's membership of a
modern and ambitious trade deal spanning 12
economies across Asia, the Pacific, and now
Europe.

The signing comes as a new government report reveals one in every 100 UK workers was employed by a business headquartered in a CPTPP member nation in 2019, equating to over 400,000 jobs across the country.

#### **Crucial Part of the US Indo-Pacific Strategy**

In international relations, strategic turnarounds are not uncommon and embedded in the very tapestry of anarchical structural realities. Yet, even by those standards, the immediacy and scale of the volte-face in relations between the US and Vietnam since the Cold War has been remarkable.

On September 2023, the General Secretary of the Communist Party of Vietnam Central Committee, Nguyen Phu Trong and US President Joe Biden met in Vietnam during Biden's visit, marking a new phase in the bilateral relationship between the two countries. (TH, 21.09.23)

#### **Super Garuda Shield 2023 Launched**

Super Garuda Shield 2023 was launched on August 31, 2023, following separate opening ceremonies attended by senior US and Indonesian military leaders in East Java.

This year's exercise is the second iteration of Super Garuda Shield, evolved from the Garuda Shield exchanges first held in 2009, and brings together seven participating nations and 12 observing nations for a combined joint multilateral exercise.

#### **India-Korea Ties in Indo-Pacific Dynamics**

To achieve its ambition of becoming a 'global pivotal state', South Korea is aiming to deepen bilateral engagements, enhance cooperation by undertaking a 'multi-layered and comprehensive approach,' and pursue partnerships with multilateral groupings and regional and global organisations.

The scope of cooperation will extend beyond just Northeast Asia to key regions within the Indo-Pacific such as Southeast Asia, South Asia, Oceania, and the African Coast of the Indian Ocean, as well as Europe and Latin America, where South Korea seeks to 'develop a network of strategic partnerships tailored to each region.'

#### **US Weighs New Military Element in Japan**

The US is weighing deploying new military elements in Japan to better coordinate with the Japan Self-Defence Forces, as a Taiwan contingency would necessitate a swift collective response.

The 2024 National Defence Authorisation Act – the country's military budget – approved by the Senate in late July includes language requiring the Department of Defence to look into modifying the US command structure in Japan. (NA, 05.08.23)

### **G7 United against China's Indo-Pacific Sea Aggression**

xpressing concern about the East and the South China Seas, the G7 members at the Foreign Ministers Meeting strongly opposed China and its militarisation and other provocative activities, and any unilateral provocative actions and efforts to change the status quo by force and coercion.

Further reaffirming the importance of peace and stability across the Taiwan Strait, the G7 members called for the peaceful resolution of cross-strait issues.
